3. Year end function and Prize Giving arrangements

3.1. Trophies/certificates:

The participation of our members at the leagues were not great this year. There is one league left on 26 Oct. According to the log to date the following divisions/categories will qualify for prizes:

Standard overall: 3

Standard senior: 3

Standard ladies: 2

Production overall: 3

Production senior:3

PCC overall: 2

PCC senior: 1

Thus 17 trophies in total.

I got a quote for trophies from the people that did it last year for us since they did a great job at a decent price.

Small trophies that the members get to keep: R100 each (17 required).

Names for the floating trophies for division/category winners R6/each (7 required).

We were short one floating trophy for a category we did not have previously (PCC senior). I made a trophy over the weekend but it will require the VTPSA badge and PCC Senior banner on it as well – I did not get an individual price for this, but it should be in line with the other quotes (<R100).

Certificates: All of the above as well as 5 for provincial colours, thus 22 in total. Quinton offered to do the printing for us again on this – thanks in advance.

FO to update the logs asap after the last league and provide the final names for the trophies and certificates.

3.2. Venue and menu:

We booked the same place we used last year for Friday 8 November (thanks Elsa).

Three menu options were received, a poll was run on the VTPSA chat group and Option 3 was selected by the vast majority (R165).

A deposit of R500 was paid in advance to the venue to secure the booking.

After careful consideration of our finances a subsidy of R125/VTPSA member was accepted by the members of the Delegates Committee. Members are welcome to bring additional guests which would be for their own account (full price).

FO will clarify finer details for the evening with the hosts and communicate on the VTPSA chat group.

We need to confirm final numbers by 1 Nov. Members will be required to pay the applicable amount for them into the VTPSA bank account to secure their reservation.
